This is a Statement of Truth

It was to be read and given to the courts in front of Judge Watters (Magistrate's Court) on July 9, 2014. It had not been allowed to be read or received because I, Stephen Clarke, born 25 June 1969, do not trust my government and choose to put my faith and trust only in God. I hope and pray that men of knowledge and understanding will receive this throughout the world and act only in good faith. May God guide you all.

If I try to deceive or lie to you I ask you show me no respite - as God is my witness this is a statement of truth.

In this courthouse, Railway Street, Lisburn, Co. Antrim, Northern Ireland on the 14th May 2014 my wife's lawyer spoke uninterrupted. When it was my turn I asked for the Right of Motu Proprio* - issued by the Supreme Pontiff Francis which has only entered into force from 1 September 2013. I was refused by Magistrate Watters, saying it only had to do with criminal matters. Nonetheless, I informed the court that I would only speak truth. As I started to explain what had me appearing in court, the magistrate badgered me and would not hear what I had to say. Then Magistrate Watters made an unjust ruling and fled her bench. I went to the administration office and they informed me that Magistrate Watters would come back out.

I waited but the magistrate did not return. Instead she sent her court staff to me saying she had given her ruling and the matter was held over until the 9th july 2014. The court staff, although sympathetic and understanding, the only way to speak the truth under Motu Proprio would be in criminal court. I informed them that I have absolute proof that our school system is harming all our children with its use of wi-fi and if the only way to speak the truth was to be arrested criminally that would be a small price to pay to tell the truth for all our children and the generations to come.

After returning home to County Kildare (Republic of Ireland) where I reside I took time to think about the best way to get a criminal charge. So I set guidelines for what would be acceptable for me. They would be as follows.

- 1) That I harm no other person in my actions;
- 2) It should be against The State as it was they that act negligently and knowingly;
- 3) It should be a visible protest that caused minimal disruption but would be noticed; and
- 4) To then speak only the truth and blame no individual.

Then, on 3 June 2014 the court without my knowledge and upon my estranged wife's request struck a non-molestation order against me barring me from contact with my children until 3 June 2016. To say the very least, I was amazed she would go to such lengths as she had always said that she knew of no better father than me. She had also warned me in the past that if I ever wronged her she would be one of the most vengeful and spiteful women I ever met. She has kept her word - no matter of the harm she has caused to our children and our family. May God forgive her. All is as God wills.

After hearing the news of the non-molestation order I decided to act. So, on Sunday evening 8 June 2014 I did so in a peaceful one-man protest climbing the commonly known "Balls on the Falls" (sculpture) over the Westlink motorway in West Belfast, severing one wire and damaging several others and putting up a simple white flage. This was in keeping

with my guidelines. It is a state monument know to government ans secret societies as their *Order Out of Chaos* symbol. (This was done on a) Sunday evening so little disruption. It would harm no person and did not endanger anyone in the slightest and would be noticed - and was. From then until now I have only spoken the truth.

Again my aim was to be arrested, call Motu Proprio into effect, and highlight the attack and harm wi-fi is going to have on out children. It will make the State Thalidomide disaster look like chicken pox if allowed to continue. However, my plan went astray as speaking the truth and raising a white flag in a peaceful protest lands you in a psychiatric hospital in Belfast. In our community you are only allowed to raise flags that incite hatred and tribalism - division. Group inanity is welcomed and promoted by our government.

Now I am a man barred by law from seeing or talking to his children, condemned and imprisoned in a psychiatric hospital for over a month with no sign of release and soon to be forcibly medicated and now, not even allowed to go to court to defend myself - all because I did not want The State to harm any of our children. I only seek justice for all our children. I wish no person to be blamed or held responsible. I want no compensation. I wish, and indeed, I pray only for justice.

The majority of scientists wourld-wide are in agreement to the devastating effect of wi-fi (radio wave technology) is having on our children. Please, for the sake of our children take your fingers out of your ears and listen to them.

The love of one's country is a terrible thing -

The love of one's children is a beautiful thing -

But the love of the Creator of everything is the ultimate thing

Please God, allow me to seek Justice for all of Your Children

Please, oh mankind, act by your conscience
